2008 Code Update Class Saturday September 25, 2010

The RECIPROCAL ELECTRICAL COUNCIL R.E.C.I." is offering an **eight (8) hour class specifically designed for sign specialists**. This class will be held at the Ukrainian Cultural Center in Warren. This is a State approved Code Update Program # 09-165-08 for all licensed sign specialists. Sign contractors, employees and helpers are also welcome to register and attend.

NOTE: This is the only eight (8) hour 2008 code update program for sign specialists that the R.E.C.I. will offer. The R.E.C.I. also has 15 hour classes' available covering the update for the entire code book.

The Sign Specialist program is scheduled to run from 7:30 a.m. to 4:00 p.m. and includes coffee on arrival, lunch and coffee breaks. **Cost for this class is \$110.00 per person.** You must bring your 2008 NEC Code book to the class as it is not supplied. You will receive handouts, USSC Technical Material, a copy of the 2008 Michigan Electrical Code Part 8 Rules and a RECI manual. Speakers will be George Little retired Electrical Inspector, John Hartigan retired Electrical Inspector, Phil Clark Chief Electrical Inspector City of Detroit and Tom Sanford with Midwest Sign Association and retired Huron Sign Company.

A CODE UPDATE CLASS IS REQUIRED TO RENEW YOUR 2011 SIGN SPECIALIST LICENSE. Upon successful completion of this class, you will receive a Certificate of Completion, for your records. We shall also forward the class roster to your licensing board as we are required to do.

All registrations must be received and paid for in advance. **Note: There will be no registrations at the door unless pre-approved by the RECI Office.** "Cut off date for registrations" is **September 22, 2010**.
